

**2017 SANDERS COUNTY FAIR DEMOLITION DERBY REGISTRATION FORM**

The 2017 Demolition Derby will have a main event and powder puff. \$7,500.00 in prize money is offered to the main event participants. 1<sup>st</sup> place pays \$3,000.00, 2<sup>nd</sup> place \$2,000.00, 3<sup>rd</sup> place \$1,500.00, 4<sup>th</sup> place \$750.00 and 5<sup>th</sup> place \$250.00. The top two finishers in each heat will receive \$50.00 each. A powder puff heat will be held if there are 5 or more entrants. The winner will receive the powder puff entry fees.  
(If you win prize money of \$600.00 or more, you must provide your Social Security Number before being awarded the prize money.)
