DEADLINE TO FILE IS FEBRUARY 10, 2020 by 5:00 PM.
NO FILING FEE IS REQUIRED TO FILE.

A candidate must be elected from among the registered electors qualified to vote at Special District Elections within the Fire, Hospital, Park, Water and Sewer District for which the candidate has filed. The candidate must be a registered voter in Sanders County and live in the District in which they are seeking to hold a position.

Per 7-33-2106, 7-34-2117, 7-13-2262, and 13-1-304 MCA, if the number of candidates is equal to or less than the number of positions to be elected for that district, the Election Administrator may cancel the election. If an election is cancelled, the governing body shall declare elected by acclamation each candidate who filed a Declaration for Nomination for that position. If a nomination is not filed for one or more position, the governing body shall appoint to fill those positions. An appointee taking office pursuant to this subsection serves that term of office as if the appointee had been elected. If an election is held, the election will be held Tuesday, May 5, 2020 in a Mail Ballot Election.
