A DS850 Vote Scanning Tabulator and an ExpressVotes are on display at the Elections Office, Sanders County Courthouse in Thompson Falls. Upon request, the voting systems will be demonstrated to any inquiring elector.

If you miss the regular registration deadline (October 26, 2020 @ 5:00pm), you may still register for the election by coming to the county election office up to and including on Election Day. Between noon and the close of business on the day before Election Day (November 2, 2020), you may complete and submit a voter registration card, but you will need to return to the county election office on Election Day (November 3, 2020) to pick up and vote a ballot. The county election office is located at the address above.
