Approval on new type E bus routes 10A, 10B and 10 C in Noxon Preston Wenz motioned to approve, Bud Scully seconded no discussion, all in favor, none opposed **Motion Passed.**

Approval of updated/amended bus routes #1 and #2 in Trout Creek Dave Whitesell made the motion to approve, Bud Scully seconded no discussion all in favor, none opposed **Motion Passed.**

Approval of amended bus routes 1A and 1B in Thompson Falls Preston Wenz motioned to approve, Kathleen Walsh seconded, all in favor, none opposed **Motion Passed.** Discussion included input from Sara Dana about the safety concerns, she and other parents have, with children being picked up at the South Hill Road bus stop. She would like a safer place like the Local Store in Trout Creek and is hoping this can be reconsidered if not now, then soon. Tony Cox shared a message he had received from Liz Stender about the same safety concerns; noting better visibility is needed and a space to offload, Bud Scully agreed the Local Store was a better spot, but that it would be up to the Noxon School Board to allow it.

Lisa Wadsworth asked if they had the choice of going to the Whitepine Cemetery Bus Stop, yes, they do, they can get on the bus at any bus stop in the district
